PASTORAL SCHEME

This Scheme is made by the Church Commissioners this 8th day of May 1998 in pursuance of the Pastoral Measure 1983, the Right Reverend Peter, Bishop of Norwich, having consented thereto.

Transfer of parish and alteration of names of benefices

1. (1) The parish of Beighton with Moulton, being one of the four parishes which comprise the area of the benefice of Freethorpe with Wickhampton, Halvergate, Tunstall, Beighton and Moulton in the diocese of Norwich, shall be transferred to the benefice of Acle with Fishley and North Burlingham in the same diocese and shall continue distinct as one of the parishes which comprise the area of that benefice.

(2) The name of the benefice of Freethorpe with Wickhampton, Halvergate, Tunstall, Beighton and Moulton shall be altered to "The Benefice of Freethorpe; Wickhampton; Halvergate with Tunstall".

(3) The name of the benefice of Acle with Fishley and North Burlingham shall be altered to "The Benefice of Acle with Fishley; North Burlingham; Beighton with Moulton".

Transfer of patronage

2. Subject to clause 1(1) hereof, and with the consent of the Bishop of Norwich (in testimony whereof he has executed this Scheme) and of the Church Society Trust, whose registered office is at Dean Wace House, 16, Rosslyn Road, Watford, WD1 7EY and Kenneth Martin Mills, Esquire, of 70, Heath Croft Road, Sutton Coldfield, B75 6RN (which consents have been given in writing), that share of the patronage of the benefice of Freethorpe with Wickhampton, Halvergate, Tunstall, Beighton and Moulton which is now exercisable by the said Bishop in his corporate capacity shall hereby be transferred to and vested in the said Church Society Trust and the said Kenneth Martin Mills jointly to the end that the right of presentation to the said benefice shall henceforth be exercisable jointly by the said Church Society Trust and the said Kenneth Martin Mills.

Coming into operation of this Scheme

3. This Scheme shall come into operation upon the first day of the month following the date of any Order of Her Majesty in Council confirming this Scheme.
